

SHOW PARTICULARS

JURY PROCESS: Only active members of the Guild will be eligible to submit up to 3 works each. Entry does not guarantee exhibition of work; juror may select multiple pieces per artist. Entry fees are not refundable. All submissions must be high resolution JPEG (1MB or higher).

JUROR: Ken Goldman is an internationally known artist, author, teacher and art juror. A recipient of numerous awards, Goldman has exhibited widely both internationally and domestically. Goldman's work is included in the permanent collections of the San Diego Museum of Fine Art, North Carolina's Hickory Museum of Fine Art, the San Diego Watercolor Society and the Zuo Wen Museum in China. The author of eight instructional books Goldman has also been featured in numerous magazines. He is a signature member of the National Watercolor Society, American Watercolor Society, San Diego Watercolor Society, International Society of Acrylic Painters and the Pastel Society of America. His education includes the National Academy of Design, and the New York Studio School. He is currently serving as president of the National Watercolor Society.

NOTIFICATION: Artists will be notified no later than April 25, 2017 via email. If you wish to have written notification, please include a SASE.

SHOW TERMS: All work submitted must be for sale; 35% sales commission to FAC. **All art is due at the Center May 8-10, 2017;** accepted artists will receive specific delivery instructions. FAC provides display pedestals and hangs the show. All shipping costs are the responsibility of the Artist; \$35 handling fee for all shipped works. Works will be covered under the FAC's Fine Art Policy; artists are responsible for substantiation of stated value less 35% commission. *No refunds for cancellation after acceptance. The Fallbrook Art Center reserves the right to withhold any work from display that does not meet established standards. We reserve the right to use images submitted and/or photograph work for promotion.*
